RESOLUTION

WHEREAS, the City of Memphis, Division of Public Services and Neighborhoods, Memphis Public Library and Information Center, has received Forty-Two Thousand Dollars (\$42,000.00) from the United Way LINC 2-1-1 service through the Foundation for the Library; and

WHEREAS, these funds will be used to fund a Database Manager position for LINC 2-1-1; and

WHEREAS, it is necessary to appropriate the funds from the Foundation of The Library to hire a Database Manager, in the amount of Forty –Two Thousand Dollars.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of Memphis that Forty Two Thousand Dollars be accepted by the City of Memphis.

BE IT FURTHER RESOLVED, that the Fiscal Year 2010 Operating Budget be and is hereby amended by appropriating the Expenditures and Revenues for the General Library Services Salary and Benefits in the amount of Forty Two Thousand Dollars as follows:
